## UKRAINE REQUIREMENTS

- 1. Clearly and completely filled in and signed Application for Ukraine entry and transit visa (available from Embassy website or Embassy).
- 2. Passport must be valid for a period of at least 3 months beyond the applicant's last day of stay in Ukraine and not older than 10 years. Please ensure that the passport has 2 blank pages to affix visa. Temporary passports are no longer accepted for entry.
- 3. Two recent photographs (colour, 3x4 centimetres). The traveller must be clearly identifiable from the picture on the passport photo.
- 4. Proof of payment of visa fee (those applying for urgent double or multiple entry visa(s) please contact the Embassy before applying): Fees must be paid in the form of electronic fund transfer (EFT) only. Cash deposits made into the Embassy's account will not be considered. In case of emergency cash will be accepted.
- 5. If not a citizen of South Africa, Botswana, Lesotho, Namibia, Madagascar, Mauritius, Swaziland, Zambia and Zimbabwe, a permanent residence permit valid for a period of at least 3 months after the applicants last day of stay in Ukraine.

## For short stay visas:

## Documents 6-14 to be submitted in original PLUS extra copy.

- 6. Proof of sufficient funds for duration of stay (equivalent of R425.00 per day). (Bank statement of the last 3 months or Letter of Good Standing from the applicant's bank or Letter from company in Ukraine stating all costs will be paid for).
- 7. For home stay visit: Original invitation of an established type issued in the applicant's name by Immigration Office of the Ministry of Internal Affairs of Ukraine in the area where the inviting person permanently resides.
- 8. For business: Only original invitation of an established type issued in the applicant's name by Immigration Office of the Ministry of Internal Affairs of Ukraine in the area where private legal entity is registered; Or official letter of invitation from the Ukrainian government institution, state organization or state-owned company.

The invitation should be on a letterhead of the government institution, state organization or state-owned company, stamped and signed, as well as state full name of the applicant, term and purpose of journey;

- Or document certifying the registration of the foreign investment into Ukrainian economy in foreign currency in the amount not less than 50 thousand USD; Or (for conferences) proof of registration and payment to be an attendee; Or (for representatives of Mass Media) letter of the Chief Officer of the Mass Media addressed to the Embassy
- 9. For tourism: Confirmed hotel reservation is requested. In the case of a prepaid tour, please provide details of the tour with proof of payment to the tour operator either Ukrainian or foreign.
- 10. For medical treatment: Invitation from the Ukrainian medical treatment facility. The invitation should be on a letterhead, stamped and signed, as well as state full name of the applicant, term and purpose of medical treatment.
- 11. For humanitarian mission: Confirmation by the Commission of the Cabinet of Ministers of Ukraine on humanitarian aid.
- 12. For religious mission: Invitation from a Ukrainian religious organization for a foreign missionary to visit Ukraine for short term purposes, approved by the Ukrainian state body, that registered religious organization.

13. **For any other purposes**: Only original invitation of an established type issued in the applicant's name by Immigration Office of the Ministry of Internal Affairs of Ukraine in the area where private legal entity (firm, company, NGO, private entrepreneur etc.) is registered

14. **Children under 18:** Unabridged birth certificate. If the child is traveling alone: certified parental consent by both parents. If the child travels with only one parent, the other parent must produce the notarized/certified consent. If only one parent has guardianship of minor, the relevant court documents must be presented.
